E-Government Practices in South American Countries:

Colombia Policy: In this case, two main stages can be identified in implementing e-government policy. In the first stage, initial actions included the publication of two laws and two policy documents in the early 2000s. One such policy document, CONPES 3072/2000, set the foundations of the "Connectivity Agenda", in which the government embarked on a path to expand the use of ICT in government procedures. Then, as Prieto et al. (2012) shows, the government issued Presidential Instruction no. 02, which laid the foundation for subsequent waves of action that have set out more concrete strategies over the past few years.

Brazil Policy: The whole process started in the 2000s with the creation of the so-called Inter-Ministerial Working Group whose aim was to study and propose policies, and guidelines to enable new forms of electronic interaction with citizens.

Brazil's e-government structure has an executive committee, which is a technical committee tasked with running and controlling opengovernment projects, together with the Secretariat of Logistics and Information Technology.

Chili Policy: hile is a highly centralized country. This trait can also be found in the way the e-government agenda in general has proceeded. Starting in 2008, the Chilean government enacted Law 20.285, and since then it has enacted a group of regulations to enforce citizens' ability to access public information
